

In the case of the State of Alaska vs. Stephen Hugo Kroschel from the Department of Law / Criminal Division dated 18th of September, 2025 and signed by Mathew R. Kaste / Assistant Attorney General ~

I the Defendant Stephen H. Kroschel plead NOT GUILTY to all FIVE counts of Cruelty to Animals .

Three of these counts are Felonies and two are Misdemeanors

I , Stephen H. Kroschel , Defendant shall break down this 15 page State Charging Document { Dossier} document with refutations as follows :

Page 1 : Criminal Charges : State asserts Animal Cruelty . Kroschel asserts the State is engaged In malicious actions using positions as state officials in a CRIMINAL capacity , and are knowingly engaged in collusion and subterfuge , that , through the preponderance of the evidence in a fair trial and due process of Law, will find the Defendant NOT guilty on all counts and will be vindicated.

Page 2.

Count # 1, in which the state accuses the defendant in that Kroschel “knowingly inflicted severe or prolonged physical pain or suffering on an animal : a moose . The state claims this is in violation of , and against the peace and dignity of the State of Alaska. On the contrary , the only individuals that are violating the peace and dignity of the State of Alaska are the individuals that created this fake “Alaskan Dossier” . The moose “died suddenly” , and that was exactly the heading on my email to the state the morning it died. And it was the twin to another moose that was in the same body condition and fed the same foods and had the same care that grew into a big , beautiful bull known as “Duck Moses” that was treated like the celebrity he was, and who was adored by visitors from all over the World. This moose roams in a multi-acre swamp and along mountain slopes with a horse trailer for shelter and treats if it should so choose. The moose had exceptional care and had a better environment to live in and food choices than ANY OTHER FACILITY IN THE STATE! There is zero proof, ZERO that I would intentionally try to inflict pain and suffering on EITHER moose. This is based on the OPINIONS of a vindictive , angry, nasty , discredited , veterinarian named Dr.Kimberly Beckmen who works within the department on necropsies and weaponizes them to character assassinate anyone she doesn’t like. I have long suspected her necropsies are fraudulent , specious and intentionally scurrilous to stifle and destroy me. I have written to the Department expressing this very fact. This suspicion goes almost all the way back to when this woman began working with this incestuous agency in 2002.. The State Veterinarian Dr. Robert Gerlach , who was with the Department of Environmental Conservation, is the one with integrity and who I consulted with from time to time. Also the current State Veterinarian Dr. Sarah Coburn. I have never met Dr. Beckmen or communicated with her directly in any way , shape , or form. Ever !

If what she and any of the other sycophantic ADFG employees say is true, why file CRIMINAL charges nearly three YEARS following the death of this calf moose? To any reasonable person, the negligence and suspicion is the Alaska Department of Fish and Game.

Count # 2 : in which the state accuses the defendant in that Kroschel “knowingly inflicted severe or prolonged physical pain or suffering on an animal : a porcupine The state jumps to this conclusion despite the facts of its age, sex , and necropsy findings that are consistent with an animal that lived far longer than it would have in the wild. The porcupine’s name was “Aquila’ and was a star attraction of the park. “Aquila” was one of two porcupines I had and the ONLY one used for virtually all tours . I have recorded the phone conversations with the pathologist surrounding its death. In no way , according to the pathologist / examiner, could this death be attributed to cruelty . On the contrary, there should be a

notation or recognition of my success at providing enrichment and a varied diet that gave this porcupine a longer than normal life ! There was a video sent of this porcupine and the second porcupine together in early October to the USDA PROVING their health and well-being. I also contacted my appointed veterinarian of the impending death of this animal because it stopped eating similar to an individual in a nursing home with perhaps 72 hours preceding death. Such was the case with this porcupine. Further, why would I intentionally STARVE a porcupine that was the STAR attraction of my tours? Why didn't I "starve" the second porcupine that wasn't part of the regular tours ? The porcupine's diet was correct the whole time. I recorded a phone conversation with a representative of Mazuri Zoologic Foods in which she confirmed this fact. Additionally , I recorded , and essentially caught USDA Inspector Dr. Ann Goplen admitting on camera that I was feeding the porcupines correctly with this food supplementation. Nonetheless, I ordered yet another herbivore food for the porcupines to show respect to the ADFG. The evidence is overwhelmingly obvious ADFG had a scheme to end my park, my reputation, and for all intents and purposes my life . They knew they had to make up "a criminal investigation" to raid my park, because they knew I would have had a crew of filmmakers documenting this disastrous raid otherwise. They knew I wanted to sue the state. They had to counter my strength with a criminal conspiracy that will one day in the future find THEM as the true criminals.

Count # 3 : My refutation of this charge uses the same logic as the other two charges but what is interesting that the raid took place on June 26th and 27th, NOT June 25th as this fake dossier states. "Kitty" the Brown Bear . a 17 year old grizzly that is treated like a human being and who lived in a beautiful multi-acre compound with a pond with a close psychological bond with me.

Under no circumstances would I knowingly inflict severe or prolong pain on my grizzly ! Why in Gawd's name would I do that ? That would be suicide ! I could be killed with the bear acting out a vindictive strike trespassing even a hot line that is her mental "fence". On the contrary, there are myriads of videos of my interactions with this bear spanning ALL the years of her life with me ; right up to a video posted on my facebook page 72 HOURS before this RAID! The Department of Law is once again fed false statements regarding the bear's overall physical condition verified as excellent by my appointed veterinarian Dr. Kathleen Doty on May 5th, 2025 AND even the USDA inspectors that came that same day including Dr. Katie Frank who looked in the bear's mouth . The Grizzly's teeth were visually examined by USDA inspectors on the 2nd inspection of September of 2024. Alaska Department of Fish and Game employees along with the state trooper also spent a great deal of time inspecting "Kitty" in her compound. Nothing was found to be wrong . Only NOW, in this charging document , on the actual day of the RAID that was already in progress does this charge get drawn up.

Page 3

Count 4 and 5 are misdemeanor charges that are categorically false and evidence of state officials engaging in the following :

- *Knowingly Falsifying Public Records/ Statement
- *Unsworn Falsification 1st and 2nd degree
- * Malicious prosecution / Abuse of Process
- * Conspiracy AND collusion with USDA officials
- *Civil Rights Violations

Page 3 continued

The ADFG and the USDA ALL: came together on the three 're-licensing inspections " by the USDA that occurred on August 27th and late September, 2024. Even the state trooper was in attendance , Colin Nemec on all three inspections. Please note that Trooper Nemec even came on the August 27th, 2024 inspection . Why would this large group of people come for a relicensing inspection ?

Answer : I reference a recorded phone conversation on August 9th, 2024 with ADFG director Ryan Scott right after my USDA License was intentionally not renewed on August 5th, 2024. That phone conversation lasted approximately 45 minutes . All recorded by me . In that conversation, Mr. Scott stated he wanted me to "Call it a day" { to quit} , in that conversation I asked him if I had BROKEN ANY LAWS , His answer "Not that we know of" ... In that conversation he explained all the effort that had ALREADY gone into finding homes for my animals ! In that conversation he described how they were going to capture and move all my animals ! In that conversation he was sure that I was going to quit and wanted to talk about ten days later.

INSTEAD I CONTACTED THE USDA and exercised my right to have the three inspections to get my USDA reinstated despite the intentional scheme to let the clock run out on August 5th, 2024. The state did not expect me to take these "against all odds" actions nor did the USDA inspector Dr. Ann Goplen who admitted this to me. She thought I would wave the "white flag".

But what did they find on that first 7 ½ hour inspection covering my 50 acre complex ?

Tiny non-compliances that were written on a piece of paper followed by a USDA inspection report. All of these small inconsistencies were remedied by me in 45 minutes expecting reissuance of my license the following day. But that was not to be. Dr. Ann Goplen changed her mind for a second inspection and instead said she was tired according to her emails. All the evidence pointed toward my efforts to not quit and Goplen's directions to stall yet again the granting of my license.

It all. Culminated with two more inspections in late September that were outrageously subjective and pedantic in "non-compliances" { By Design.}

There was NOTHING mentioned in these USDA inspections that these charging documents are accusing me of ! And for 33 years, virtually every single USDA inspection was "NO non-compliances" !!

INCLUDING Dr. Ann Goplen's LAST inspection of my facility on October 4th, 2022. NO non -compliances !

Ultimately, the USDA denied me my license renewal ONLY because of a tiny gap under a perceived perimeter fence.

NOTHING about dirty water, NOTHING about piles of animal excrement.

NOTHING about anything but a small GAP under a reindeer fence that Dr. Goplen wanted, {and needed} to state was my perimeter fence because she was too unhealthy (and lazy) to walk up a hill with her

entourage to view the REAL perimeter fence ! { I made a youtube video about this }.. ,but moreover they needed that excuse to prevent the license from being reinstated.

So, the USDA denied me my license, and according to the rules, I would have to wait six months before reapplying for a new series of inspections. I reported this to the ADF&G ; and Ryan Scott now thought he had the perfect excuse to shut me down . The whole collusion plan worked.

OR SO HE THOUGHT !

I filed for a federal hearing to uncover this dishonesty and argue my case about the gap under the fence. The Federal Hearing was set for January 17th, 2025. The Alaska Department of Fish and Game were made aware of this action , and this is when in December,(as written on page 3 of this Alaska Dossier) that the state tried some new way to shut me down using Alaska Wildlife Trooper Colin Nemec, the SAME disingenuous individual that was present for the three USDA inspections beginning in August !

This time it was sudden concerns about 29 animal mortalities over the past five years. Never mind the fact that virtually each mortality was and is verifiably NOT due to negligence but, also that the number is FALSE! My annual report shows my mortality reports and the date and time and cause. Furthermore, my annual report shows the AGES of my family of animals . What are those ages ? Answer : 24 year old pine martens . 20 plus year old weasels. Foxes, mink , porcupines, wolverine , lynx, . living four to five times LONGER than normal!. Who else has animals that live that long ? Answer : NO ONE !

Look at the other facilities in the state including such as the Alaska Zoo , Alaska Wildlife Conservation Center, the ADF&G's own research facilities in Palmer and in the Kenai : Animal escapes , bites, deaths, galore ! In fact the publicly open USDA reports on the ADF&G facility in Palmer as recently as 2022 found the ADF&G WITHOUT even a veterinarian care plan and inflicting pain and suffering on research animals without any oversight !

EGREGIOUS and CRIMINAL ! It is public record ! Where's the media outcry ?

Page 4 :

Stephanie Bogle states I starved my porcupine to death. She is guilty of false information by Report and unsworn falsification in the first and second degree over and over again. This is a felony and she should be fired.

Further evidence of Conspiracy and official misconduct and malicious prosecution and False Information by report are even the dates in this charging document and the circumstances surrounding the death of wolves and a fox. The permit officer at the time was Tom Schumacher, a vindictive , abusive officer that used his position to destroy my business calling me a "Time Sink". He refused to give me my permit and called the USDA to shut me down over my handling of the care of poisoned wolves, not from rotten meat, but actual POISON intentionally put in the meat by some psycho who donated it. Whatever the cause, an official investigation was initiated by Shumacher, and the USDA sent high level officials to investigate and found NOTHING wrong at all and I was completely vindicated ! The charging document doesn't say anything about that . This is a crime : FALSE INFORMATION BY REPORT. I WOULD ADD Malicious prosecution. And why would the Department of Fish and Game, under the direction of Ryan Scott go back nearly 18 YEARS NOW and put THIS in the charging document ? They know this is false !

At the bottom of page 4 the document cites a USDA inspection report of a single water cup had a "moderate buildup of rust " . No it didn't . That is an optical illusion but that is one water receptacle of over a HUNDRED water receptacles . Nevertheless, 95% of my USDA inspections over the span of 30 plus YEARS are spotless. Even the Chilkat Valley News reporter couldn't find much of anything in historical USDA inspections of my facility, as written in an article of August 2024 regarding this.

The same cannot be said for OTHER facilities in this state including ADF&G's own facilities as alluded to earlier in this refutation.

Page 5:

The charging document now goes back 6 years to another phony claim that I was starving animals as reported by a woman , Sidney Campbell, who sent a false report to the state. More on her later. But ADFG's new veterinarian they hired, a Dr. Mortenson, along with a new permit officer by the name of Tim Spivey showed up at my mailbox in November of 2019 . I recorded this unannounced visit and asked them what was wrong. They would not tell me who told them I was starving the animals. I opened up over ten freezer lids that filled to the top with feed . They left in embarrassment.

Now back to Sidney Campbell. This woman hated the founders of the American Bald Eagle Foundation – Paraplegic Dave Olerud and his wife Charlotte. She BANNED Dave Olerud from even coming into his own foundation ! This woman Sidney Campbell knew I was friends of the Oleruds, and told tourists in town off cruise ships to not even VISIT my facility for tours ! Tourists would tell me this who came anyway. This woman finally was replaced.

At no time did I ever run out of quail- a specialty food for weasels , martens and birds of prey. The situation was INSURANCE as backup in case of weather delays with shipments. That was how far ahead I planned. At no time did I ever speak to this Sidney Campbell and make such statements , the person that ran errands for me was a homeless man that I took in 25 years ago named Rocky Seward. He is the person that would pick up such packages AND also deliver a payment of not the same amount of frozen quails , but 20% MORE product back to them as a "thank you". Eagle Foundation Director Cheryl McRoberts , is witness to this and can also testify to the nastiness of this Sidney Campbell .

Regarding trapping squirrels for food. I purchased a trapping license every year { obviously can be verified} NOT because I was desperate, but because adding squirrels is a supplement to marten, weasels and raptors !

Be that as it may, the inspection and verification by Dr. Mortenson { who quit his job with ADF&G soon thereafter and was afraid to speak without permission from others in the department } AND Tim Spivey the permit officer { who also quit his job as permit officer thereafter} , should have put this incident to rest ! So why devote any space on Page 5 to this lie ? This is again : UNSWORN FALSIFICATION.and FALSE INFORMATION BY REPORT.

On the bottom of page 5 , the charging document alleges I was negligent with a wolf named "Luna" . The wolf became suddenly ill and was immediately attended to by TWO veterinarians around the clock . Dr. Michelle Oakley and Dr. Elizabeth Wolfe. This entire description and alleged neglect is FALSE INFORMATION BY REPORT./ OFFICIAL MISCONDUCT. Malicious Prosecution .

The reason this wolf died so young is due to vaccines that were administered to her as a pup before import from Minnesota. I protested the administering of certain vaccines that could cause renal failure and other conditions almost immediately and even asked Bill Thomas , our Haines representative to intercede at my behest to convince Ryan Scott to not have that as a requirement. Mr. Scott would not budge. I flew to Minnesota to pick up this wolf and as soon as it received these vaccines it began to drink water like no other wolf I've ever had in my life . I knew it was living on borrowed time . And I was right.

Page 6

Much of this page I have already gone over on the first two pages. The statement by Dr. Roug on September 3, 2025, nearly three years after the decedent moose calf is nothing but worthless conjecture steeped in bias because she is a paid employee by the ADFG. Even worse, her accusatory

conclusions are a sign of her incompetence because it is impossible to prove. The only proof is that the other calf, the twin lived and thrived . Fed the same diet and treated the same and was stolen from me on June 26th, 2025 . His name was “Duck Moses” .

The accusatory tone of the death of the lynx is again based on false reporting and opinions. All Lynx are dewormed on a schedule of fenbendazole. As is to be found in my daily logs .All of my lynx lived far longer than normal except one . More on that one later .

Dr. Roug accuses me of not giving medical attention to my lynx. That is false information by report . The lynx that died had a full body medical exam { as did other lynx} just before its death and is part of an episode of “ Dr. Oakley Yukon Vet” . That should end all discussion and point again to CONSPIRACY / OFFICIAL MISCONDUCT of this Charging Document.

The accusations of animal food supply are completely false. This is just a simple accusation without proof of any kind . Same with “fecal matter inside enclosures “ over and over again . Absurd. These officials come ONCE a year in the summer. My USDA inspections up until 2024 were , by comparison to any other facility in the state PERFECT. Perfect. PERFECT! It is documented.

Further, I hired an attorney , Bruce Wheyrauch, to represent me to the ADF&G. I spent tens of thousands of dollars for him to defend me for several years until he retired last year. We established an extensive veterinary care plan and many other contingencies to satisfy the state.

The state did NOT require me to vaccinate animals . It stated vaccinations OR deworming !

This veterinary care plan was updated and read and approved and submitted and reiterated from 2018 all the way to this past APRIL / MAY 2025 !

It should be noted that for every email that is cited in this charging document by the ADFG, there are FIVE emails from me , on average , asking questions that remain unanswered.

Page 7

The yearling moose jumped through a Dutch Door that was opened for the public to pet and feed the moose. A system that had been in place for over 20 years. The reason it jumped out is because I had an assistant who stepped away for a moment and the moose jumped out. It not “escape” due to a compromised infrastructure. It was enclosed in a secondary yard that was under construction due to the ADF&G demands that were never a problem previously. The fence was unbeknownst to me not close on one end because workers had not finished their job. The moose ultimately returned to the park – testament to the bond it had with me. The State goes on to assert that I feed the moose bananas on a daily basis . I repeatedly stated to them this is false and yet it shows up in the charging document. I would only offer a banana once in a blue moon as a treat . Such was the case upon the moose’s return as seen in youtube videos.

If this was a repeated escape situation , like the Alaska Wildlife Conservation Center losing a grizzly bear, a wolverine , and moose that break out and wood bison all over the Seward Highway, you might have a point, but this was the ONLY “escape” in 25 years and the moose returned ! UNLIKE the AWCC , for example where the grizzly bear and the wolverine and other animals NEVER returned ! Where are the charges for them ? Or the Anchorage Zoo ?

The lynx death was an anomaly. It was young. I requested the necropsy and again the state weaponized this lynx death as my fault. This lynx had a huge enclosure in natural surroundings. Stephaniw Bogle states it was “not properly cared for “ . FALSIFYING BY REPORT . Stephanie Bogle has no proof , just an opinion. The lynx died suddenly. I have video documentation of its enclosure and what happened .

The charging document states that I told the state I was “broke and no longer had sufficient funds to operate KFWC” . Really ? On December 12th, 2023? Why would I say that ? That would be suicide.

Provide proof !!! Again FALSE INFORMATION BY REPORT. Now you are falsifying public records too as a state official. A potential felony! I have a recorded phone conversation with Trooper Nemec who tried to reiterate this falsehood over the phone and I SHUT HIM DOWN!

The fact is that the state WANTS this narrative , it NEEDS this narrative to besmirch and destroy me and put me in prison.

I did indeed lose a lot of money during the pandemic as did many others. Unlike others, I survived and continued WITHOUT the assistance and support of the ADFG because they wanted to sanction me and do a soft kill by one denial after another. Tightening the noose to the point I could not do filming on or off my property or even take an animal out on a leash ! Or even TOUCH the moose anymore !

The state was out to destroy everything I had and did.

Regarding log books, I had those available for the state to look at and they refused to do so in September of 2024. The USDA, on the other hand, snapped pictures of each and every page. The ADFG simply walked away.

Page 8

The diet for the porcupine , bear and other animals is superior to that fed in zoos anywhere. I do not feed the grizzly bear just “marion berry pies” and the porcupine “just biscuits”. The video documentation I have CLEARLY proves this otherwise : and it would have been part of the Federal Hearing on January 17th, 2025 in which my license was reinstated.

The bottom of Page 8 resorts to boilerplate nonsense that is clearly false from explanations given on other pages.

IN CONCLUSION , pages 9 -15 turn into a collection of false statement by ADF&G employees.

A few salient remarks in the affidavits must be addressed as these statements by Dr. Beckmen, Dr. Roug , Stephanie Bogle, Riley Woodford , and last but far from least , the Director (Ringleader) of this Three Ring Circus Ryan Scott. Every time they open their mouths they dig themselves a deeper legal grave and it will be my aim to make sure they are indicted for what they have stated knowing full well they are lying. Dr. Beckmen has dredged up ; and promulgated a total myth from nearly 18 years ago on page 10 and 11 . This entire narrative was long debunked by the USDA investigators and the book was closed on this counterfeit narrative created and fostered by Beckmen and Tom Schumacher , the other man of malice serving as a corrupt permit officer

IF what she said IS TRUE, then why didn’t authorities raid my facility almost 20 years ago ? The burden of proof then, as now , is on the ADFG to bring forth damning evidence , and there is none. The proof of what I say here as the truth , can be easily verified in documents easily obtained directly from the USDA OR from yours truly ! The fact that this counterfeit story is in this charging document is an indictment of the credibility of especially Dr. Beckmen.

AND :

Once again , ALL of you are guilty of FALSE INFORMATION by REPORT and UNSWORN FALSIFICATION in the 1st and 2nd degree ; and with MALICE. All potential felonies.

And then there is Dr. Roug with her two cents about my” inexperience “with moose . Her opinions are nothing BUT that . And she has zero evidence to back them up , other to suggest she is a highly biased

individual willing to cast aside being a true professional to engage in ad hominem. She goes on to state the compounds are “dark” , “small” , ‘very unsanitary” etc... She continues to throw out accusations of dehydration and “hair coats” of the foxes were in poor condition ! Any veterinarian that would say that a fox has a “HAIR” coat is already in trouble. Foxes do not have HAIR , they have FUR . And any competent veterinarian that works with wildlife knows that furbearers such as foxes SHED and are aesthetically displeasing to many in JUNE – the peak of fur shedding ! Some foxes rub and are nearly bald where others maintain a decent coat of fur – it depends on the genetic line. Roug uses words like “LIKELY” . Her conjecture reaches a high point of absurdity when she ASSUMES that a three legged fox in a crate in a bus along my son’s driveway had no water or care. On the contrary, the three -legged fox is treated with more care and attention than ANY of the rest of the foxes comparatively speaking ! The fox was put in that bus with food , water and clean bedding, an HOUR or so before I arrived on the late morning of June 26th! Who put the fox in that bus ? My partner who worked all through the night before my arrival from Skagway – retired wildlife trooper Patrick McMullin. We use the bus as a drop-off point for foxes , martens, mink and even one of the lynx for training purposes on the four wheeler and in familiarizing them with the interiors of vehicles as TRAINING strategies . ENRICHMENT.

I have repeatedly told the Commissioner in videos and emails that we’re are constantly “moving animals” around. But all that is ignored in an erroneous assumption that a “fox is locked in a bus”. When in fact I was about to take that three -legged fox on a walk on a LEASH ! Again, you are guilty of conspiracy and unsworn falsification .

Roug continues her defamatory narrative and unprofessional conduct by stating my brown bear has abrasions and a skin condition as well as tooth challenges. She seems to have no experience with bears at all in that , like foxes, bears SHED FUR in clumps in the month of JUNE , JULY and then in August new fur comes in . During May and early June, my bear had several large metal plates she played with in her a lair at night and would balance them on her CHEST , thus RUBBING OFF THE FUR that was already hormonally set to be shed! . Further, her teeth have been examined multiple times by the Department that brags about all the inspections with the USDA , why didn’t they say anything ? Answer : Because there was NOTHING indicating these problems . I would like to add bears have a foul breath to begin with , depending upon what they’ve eaten.

Now , regarding Roug and her assessments on necropsies of any animal , especially Lynx :

Many of these necropsies are all done within your own incestuous department ; and with the titles you hold, you feel you have license to castigate and condemn a man for a “crime” he didn’t commit.

Dr. Roug could not even make eye contact me when I met her ONE time , ever, on MAY 8, 2024 when she trudged up the hill with her marching orders already inculcated into her psyche to end the career, (and life in a def facto sense) of yours truly. I believe that she, like Beckman, falsifies necropsies and then uses these falsifications to further destroy someone’s life and reputation. Roug lacks all credibility just like Beckman and I can prove it in paper trails.

As a side-note, why in the heck has no one ever heard of chlorine dioxide ? You accuse me of using a “swimming pool” disinfectant . This suggests a lack of knowledge of how to remedy a problem you created that you think I had about water receptacles that, as a result of showing a desire to comply with you phony new problems you find with me , you instead now use my remedy to ADD yet another strike against me !

Wow. Chlorine Dioxide, if used properly is highly effective and healthy – IF YOU USE IT PROPERLY. Which I did . Do your research .

Another huge disappointment is Dr. Michelle Oakley who has not answered any of my emails for about two years. She ignores me . Now I know why. Oakley seems to have sold her soul to the devil too in

misleading statements about why she “refused” to be my official veterinarian years ago. The truth is the other way around. I refused HER ! Why ? Because she wanted to vaccinate every single animal at my park on a regular basis with unproven vaccines that could have potential life shortening outcomes and adverse physical and psychological repercussions , especially for “Kitty” the grizzly and the wolves.

I am all for deworming however, but she threw that in as well in her affidavit that I did not want to cooperate with her

. Let me just say that there are TWO Dr. Oakleys . There is the t.v. Dr . Oakley, and then there is this “other “ Michelle Oakley that makes me want to vomit with her backstabbing at this stage. I have no use for such a person . I am learning that it everyone involved on the state side is pretty much a cluster of frogs engaged in an orgy of back scratching . Vaccines can be highly effective , OR highly dangerous . I am extremely well versed on both sides of the vaccine story . And that includes the covid vaccines which I did not take personally but Oakley did. I’m not surprised at this point.

As a side note, for all the professionals involved here, why isn’t anyone explaining all the animals that are dead at the other facilities in the state ? If she is not aware of her lie, then she is grossly incompetent. Because to assert such a thing to fortify multiple felony charges provides additional evidence of deception by a state official and is punishable under multiple definitions.

I shot videos of the “army” of troopers at my mailbox! I spoke to the troopers . My partner had just left the park as discussed earlier. Complete lie but it is an indicator of this ENTIRE fake charging document’s reckless style hell bent for leather to destroy completely my life .

The same goes for Roy Churchwell who lied about not being informed of “hormone shots” not needed for my bull moose “Duck Moses” last September, 2024 , when he stumbled along with his hands in his pockets playing dumb the whole time. When in fact, he is a “paid employee” who is really a paid informant ; for his own selfish “job security” ; and to say whatever is needed to ruin the legacy of the wildlife park and yours truly. His statements about dirty water receptacles post raid and other filth is absurd. His dishonesty and spineless way he presents himself is a exhibit “A” in the worst of government stereotypes.

A retired police officer by the name of Rodney Hinson along with yours truly recorded the condition of water receptacles and bedding for animals after the state vandalism and the record indicts Churchwell completely.

Ditto for Riley Woodford. He can't decipher anything when it comes to the Grizzly's lair

. It is impossible to understand to an outsider. And for him to open his mouth and call it "Jury-Rigged" -- is shameful. Then he attacks "Kitty's " water cup . What he doesn't understand that a metal water cup like that is filled with fresh clean water four to five times a day even when she swims in the pond. I would even drink out of that water cup it is so clean ! Further, if she had abrasions on her feet from barb wire, if that is true, it is from barb wire wraps in the corners of her lair to discourage her from digging where there was a requirement of upgrades since the winter break-up of certain pieces of cement . I wanted to try barb wire to discourage her from digging.

Something else that should be mentioned here is that I have not had an income , NONE , since August 5th, 2024. The entire park needs constant maintenance 24/7 , and I was achieving that DESPITE the fact that YOUR DEPARTMENT PURPOSELY SANCTIONED ME to fail. You pretended I could get a permit yet waiting another over ten months to finally come . Why did you wait so long if I am cruel to animals ?

Metaphorically speaking , would you get on a jet that is on "E" at takeoff for a transoceanic flight and expect it to make it to its destination ? I assert that you purposely wanted to blockade me until things started to crumble so you could find "something". You found NOTHING on June 26th and 27th. Instead you killed and traumatized and let animals escape and left a handful more. YOU are the guilty party !

And then there is Ryan Scott, an individual that has abused his ladder- climbing position for many years and deserves to be punished to the fullest extent of the law. A judge recently ruled he "lacks credibility" in another case involving wolf and bear culling in the interior of Alaska. I have a special place in my heart for Mr. Scott in that I look forward to his future jurisprudential punishments that I will pursue until my dying breath. Innocent people fight back . And Scott's behavior , along with his partner in crime Doug Lang will be exposed . Your charging document is a prime example of what the Government can do in SUBVERTING THE TRUTH if they don't like you . If you fight back

Scott's conjecture about maggots in a tote with a rotting animal corpse(it was a wolverine carcass from a trapper for normal decomposition before bleaching bones) to his fibbing about dirty water and feces in enclosures { can prove false by videos post raid with a police officer present and Charlotte Olerud as an additional witness) I have sufficient evidence both in video form before and after and during the raid , along with testimony and witnesses to the vandalization and mistreatment of my animals, including what led to the CRUEL death of "Meluna", my dear wolf in the DOT building in Haines, to discredit this pathetic character.

He will be held accountable for his lies. From his statements in August , 2024, to his phone call to Patrick McMullen in early January, 2025, not to mention his inconsistencies after my so called "application" was reviewed this March and April ,

I vow to go after this guy to the fullest extent of the law , not to mention media opportunities to bring TRUTH TO LIGHT.

Shellene Hutter, an employee of the Department of Fish and Game had the backbone to stand up to you , Mr. Scott, and you tried to shut her up.

Your other Troll in the office , Assistant Director Mark Burch, lied to her about what it would take to get my permit to operate in this spring . All lies . We believed Burch. We withdraw our protective orders

and I ordered my veterinarian of record, Dr. Kathleen Doty to fly down immediately to examine my animals on May 5th, as Burch claimed would satisfy your Department's desires.

On the contrary , ADFG lied again and proved the agency's malfeasance by arranging for the USDA to bring a TEAM of contracted people to come the same day : MAY 5th, 2025 for a final "showdown"!

I recorded almost completely that day for the documentary I am concluding in Russia.

And what ADFG and the USDA did in this elaborate cross -country fiasco is all at the taxpayer's expense , of course.

Your careless and reckless and entirely botched raid resulted in the death of "Meluna" the wolf in the Department of Transportation Building in Haines . You killed my snowy owl. You killed a fox. You traumatized everyone.

The ADF&G led by Ryan Scott and Trooper Nemec conducted a raid which led to the escape of multiple animals , and the trauma of all the rest . The search warrant was inaccurate stating three lynx were taken and three "wolves" . Many animals were left behind that are still remaining at my destroyed facility now going on FOUR MONTHS LATER ! How do you explain THAT ?

The State of Alaska should be aware that my partner who assists me is a former state trooper himself for over two decades and has worked with me for over a decade.

Recently, I was made aware of the protective order that I filed in March against the state that was dismissed by Judge Woolford. I have been notified that you have garnished my PFD of \$1,000.00 . Just to rub salt in my wounds. What a disgrace! Explain how a man who is cruel to animals would file court papers to keep you people from taking them because it would lead to exactly what happened in late June and is still happening.

Perhaps the greatest irony of all is ADF&G accusing me of animal cruelty, when for years I spoke to the public about the need to save baby wolverines in the ARCTIC of ALASKA.

The TRAPPING SEASON on this species doesn't close in many areas until April 15th! Wolverine kits are born in late February and early March. Therefore , while their MOTHER is snarling and biting at the end of a leghold trap chain, for perhaps days, and where they chew off their frozen toes or even their foot, the babies die of exposure and starvation in the dens. And if the mother successful breaks free, she will spend the rest of her life with three legs and a stump.

Can you imagine the pain and suffering ? ADF&G knowingly and willingly engages in inflicting prolonged pain and suffering on THOUSANDS of animals every winter during the trapping season.

And Stephanie Bogle, the same woman that accuses me without evidence of cruelty , coordinates this massacre of fur along with the other criminals in this agency.

Double standards and Hypocrisy ? You know the answer.

The battle against this injustice has just begun.
